



# SWIPO IaaS and SaaS - Template Declaration of Adherence, version 1.1

This declaration of adherence ("**Declaration**") allows an Infrastructure Cloud Service Provider ("**Infra CSP**") or Cloud Service Provider ("**CSP**") to declare its voluntary adherence to the Code of Conduct for Data Portability and Cloud Service Switching for Infrastructure as a Service ("**IaaS**") Cloud services ("**IaaS Code**") and/or the Code of Conduct for Data Portability and Cloud Service Switching for Software as a Service ("**SaaS**") Cloud services ("**SaaS Code**"), respectively for the IaaS services ("**IaaS Services**") and/or SaaS services ("**SaaS Services**") they identified below. Unless they are otherwise defined, capitalised terms used in this Declaration will have the meaning given to them in the Code.

By completing this Declaration of Adherence, the CSP is declaring that it is complying with the requirements set out in the Code for the Services it chooses to declare.

This Declaration shall be submitted by the adhering Infra CSP or CSP to the Secretariat of SWIPO AISBL and will be valid for a period of up to thirty-six (36) months once published in the Public Register unless the Infra CSP or CSP decides to withdraw its declaration before then.

The fee per product or service declared is 1,500 EUR for non-member and 750 EUR for members. The CSP or Infra CSP hereby agrees to pay the fees published by SWIPO AISBL for each service or product it declared in this Declaration.
